Surf Sports Competitors Agreement



Overview This competitor's agreement outlines several guidelines for each TH&C SLSC member to meet to participate in surf sports activities and competition throughout the **2024/2025** season.

Patrols

- All members shall be listed on a patrol group/roster for the season and are to attend all their rostered patrols (approx. 40hr).
- If unable to attend, members are to arrange their own substitute and advise their patrol captain.
- Members who miss rostered patrols are to make these patrol hours up.

Training

- High visibility garments (ie. rash vests) **MUST** be worn when participating in all water-based training/activity. Those not in hi-vis will be unable to participate (SLSQ policy).
- Those attending training must record their name in the attendance logbook (located in Training room & Board Shed).
- Ensure that nominated coach has signed off the session.

Equipment

- Use of club equipment is determined by the Surf Sports Committee and Club Coaches. Allocations of club equipment for members will be made by Coaches and relevant SS captains. If any equipment is damaged, members are to notify SS captains ASAP.
- If Personal and club craft/equipment are stored in club sheds. Do not use what is not yours. If members have any questions, they are to ask relevant surf sports captains.
- Allocation of club storage will be through application to surf sports committee, If storage numbers are exceeded a ranking policy may be required and applied.
- Ensure that club sheds are locked following club training/activity.

Competition

- All surf sports competitions are listed in SLSQ Surf Sports Calendar (placed on club notice boards, attendance logbooks, club website), also in TH&C SLSC club calendar, and as per listed club endorsed events as approved from time to time by the Board of Management.
- Members interested in attending carnivals are to fill in the entry nomination list (found in club office, club notice boards), or notify Surf Sports Captains or surf club office.
- All members wishing to compete at Championship events (ie. QLD State, Australian, and World Championships) are to complete expression of interest. This is to be approved by the selection committee and the Board of Management.
- If members can't attend a competition where they are already entered, they must inform the club ASAP. Failing to do so may incur a financial penalty to the competitor.
- Competitors are responsible for gear transport to and from carnivals
- Transport may be provided with club trailers to larger carnivals or if many competitors are attending, interstate carnivals may have additional further costs.

Fundraising

- Members are required to attend fundraising activities set out by the Surf Club and surf sports committee to contribute to the costs of surf sports activities (ie. surf safe appeal, raffles, rostered or organized events, working bees, and other approved events)

Meetings

- Competition/training members are required to attend all competitor's meetings. This is to provide essential info/updates to members, along with upcoming events/activities.
